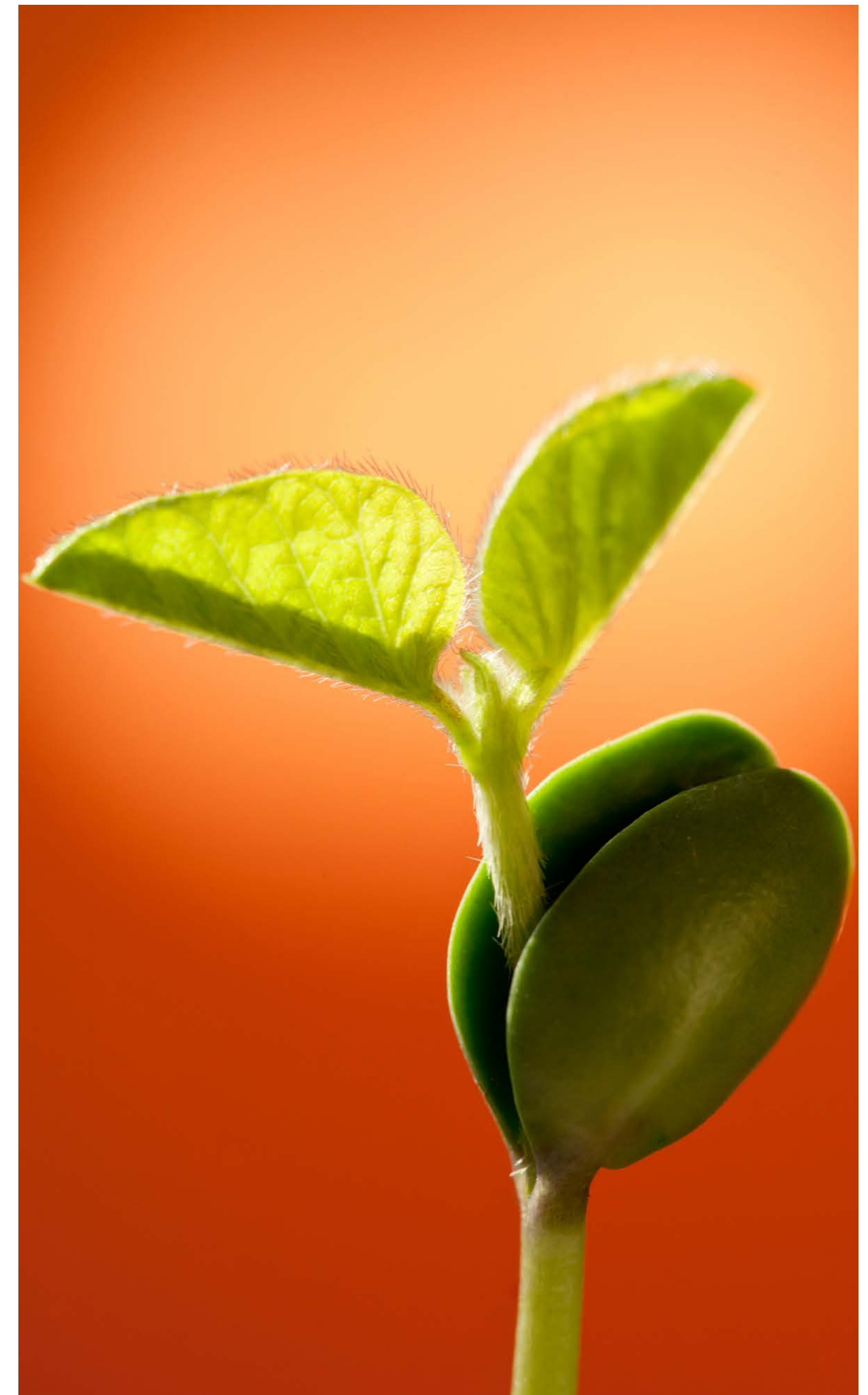

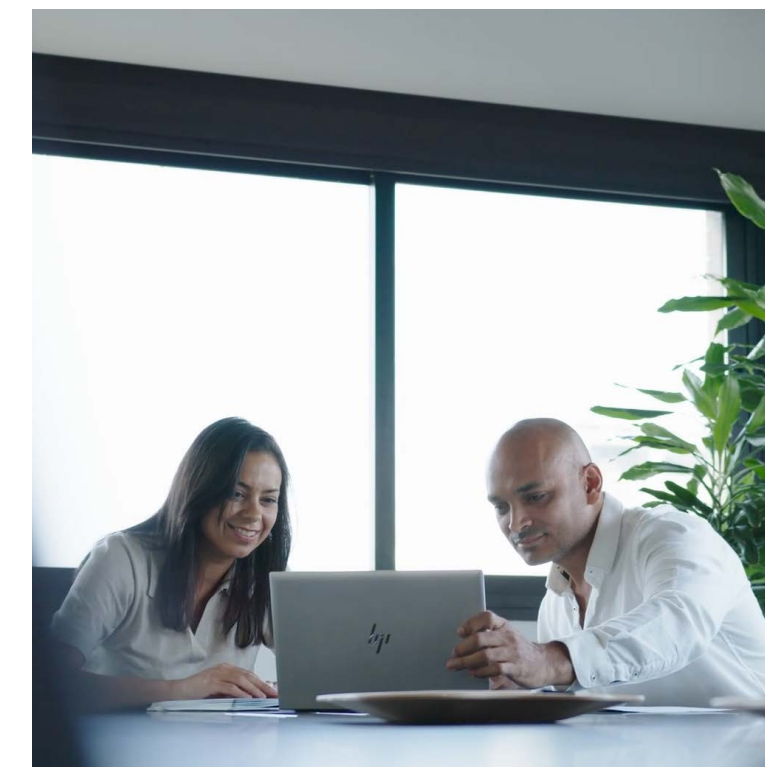

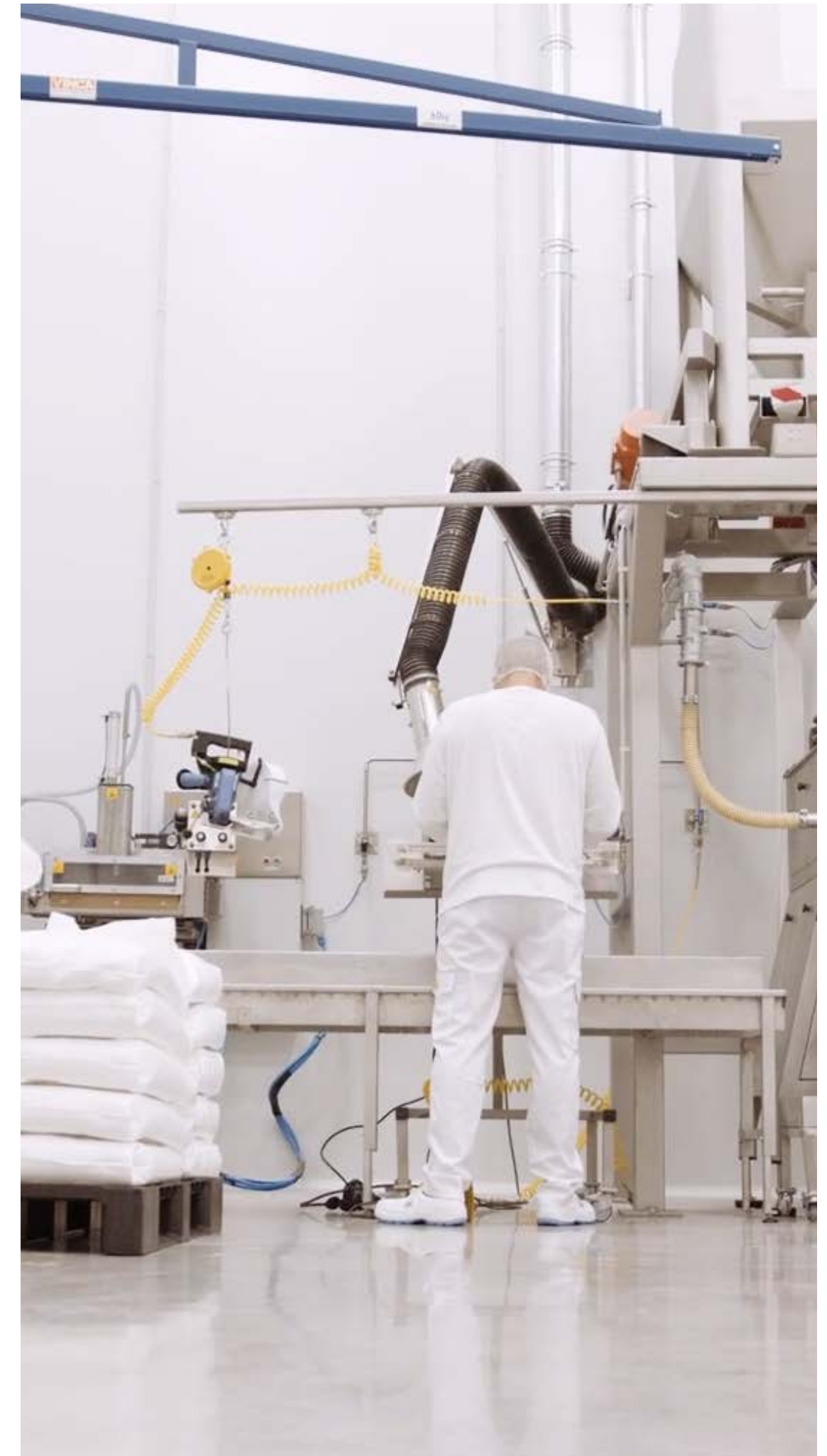

- **Quality management** and analytical controls in our own laboratory.



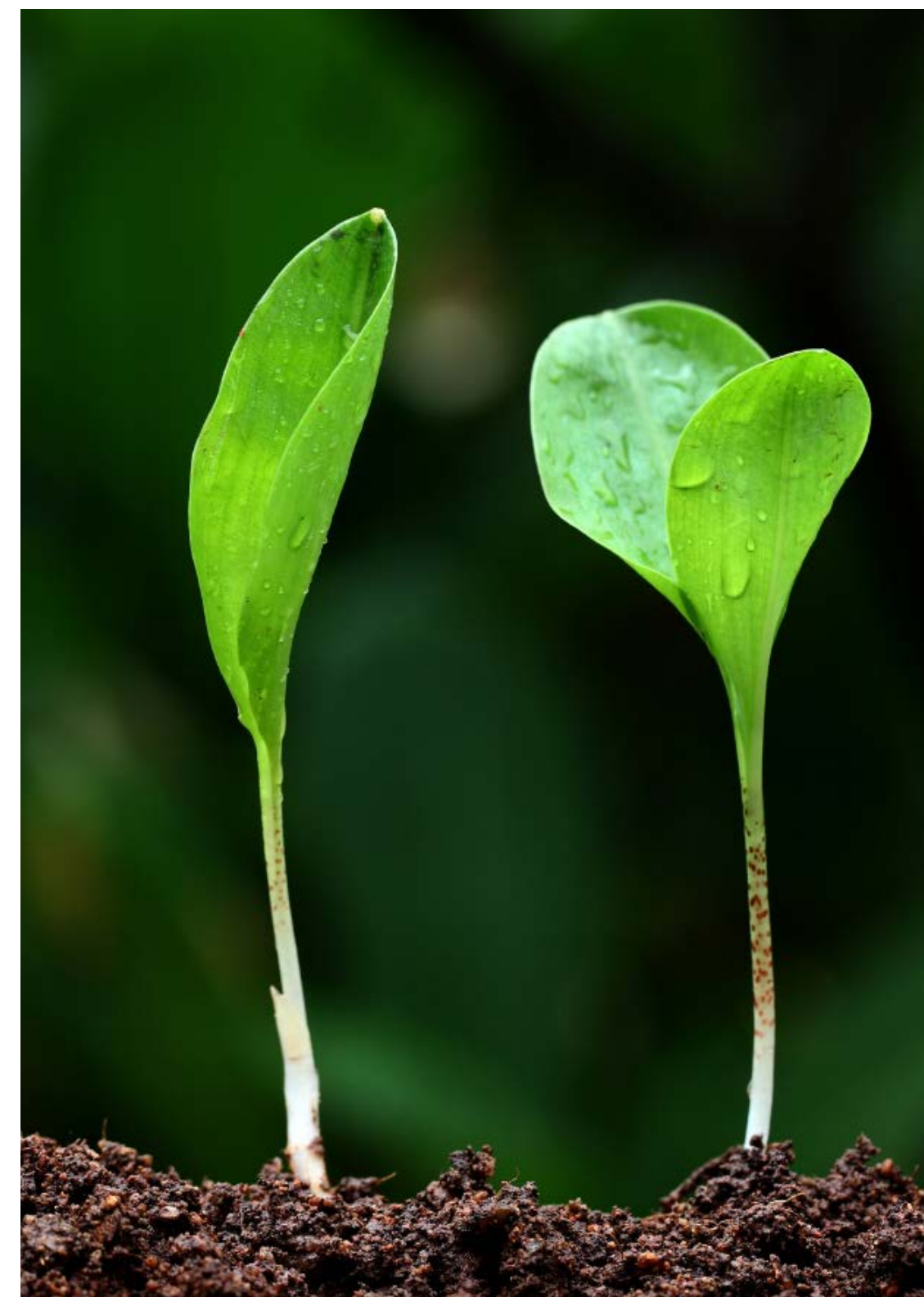
